BSKS and Mr. Strafer have litigated some of the highest-profile federal appeals in recent years: *United States v. Ignasiak*, 667 F.3d 1217, 1220 (11th Cir. 2012) (vacating conviction of medical doctor because the trial judge abused his discretion by allowing the introduction of autopsy reports in violation of the Confrontation Clause and the Rules of Evidence); *United States v. Lopez-Vanegas*, 493 F.3d 1305 (11th Cir. 2007) (vacating conviction of real estate broker because the trial judge erroneously construed U.S. drug laws to apply extraterritorially); *United States v. Peter*, 310 F.3d 709 (11th Cir. 2002) (vacating conviction of nightclub owner because the trial judge erroneously construed mail fraud statute to criminalize misrepresentations on an application for alcoholic beverage licenses).

BSKS holds the rare distinction of having had two Petitions for Writs of Certiorari granted by the Supreme Court of the United States in the last three years, scoring a landmark victory in *Luis v. United States*, 136 S.Ct. 1083 (2016) (holding that the Sixth Amendment exempts from restraint and forfeiture untainted assets needed to retain counsel of choice).
